PRESIDENCY OF THE COUNCIL OF MINISTERS

Resolution of the Council of Ministers no. 141/2019

Summary: Approves the National Implementation Plan of the Global Compact for Migration.

The Global Compact for Safe, Orderly and Regular Migration was approved by the General Assembly of the United Nations on 19 December 2018 (Resolution A/RES/73/195). The Compact is based on 10 guiding principles which promote a vision centred on people, international cooperation, national sovereignty, the Rule of Law, sustainable development, respect for human rights, gender equality, the best interests of the child and a holistic approach to migration, while involving all levels of the Administration and civil society. These principles are reflected in the 23 objectives of the Compact and will continuously be implemented by the signatory States through national plans. In fact, in paragraph 53, the Compact « encourage[s] all Member States to develop, as soon as practicable, ambitious national responses for the implementation of the Global Compact, and to conduct regular and inclusive reviews of progress at the national level, such as through the voluntary elaboration and use of a national implementation plan. Such reviews should draw on contributions from all relevant stakeholders, as well as parliaments and local authorities, and serve to effectively inform the participation of Member States in the International Migration Review Forum and other relevant forums ».

The Global Compact for Migration foresees the constitution of an International Migration Review Forum which, as of 2022, shall hold meetings every four years and work as the main global platform for sharing and debating the implementation of goals at local, national, regional and global levels.

Portugal has been committed to the process leading to the elaboration of the Compact since its launch, on September 2016, until its conclusion, two years later. It now aims to be one of the first countries to deliver and execute the Plan by immediately approving the respective National Implementation Plan.

The Plan follows the structure of the 23 objectives that comprise the Global Compact for Migration in order to cover all the relevant dimensions of the migration phenomenon. Implementation measures are defined for each objective, and the respective implementation deadlines and Government areas involved are defined. The Plan is therefore designed as an operational document, geared towards practical and accurate results.

The objectives and measures of the Plan enable the design of a national response on migration matters, in line with fundamental international partners. That response is organised around five fundamental axes.

First: the promotion of safe, orderly and regular migration as the most effective way of framing human mobility, managing demographic dynamics and enhancing their contribution to the development of countries of origin, transit and destination. Examples of measures included in the Plan which fall under this basic guideline are *i*) the approval and implementation of the Mobility Regime of the Community of Portuguese-Speaking Countries (CPLP), *ii*) Portugal's bilateral agreements with third-party States for the organization of labour mobility flows, and *iii*) the mechanisms for attracting specific groups such as students, academics, investors and professionals to Portugal.

Second: the improvement of the processes of organization of migration flows and integrated border management, namely as regards visa applications and permits required for regular immigration and border security, by combating human trafficking, containing irregular migration and promoting document security. Examples of measures contained in the Plan that fall under this guideline are i) the incorporation in the residence permit title of information equivalent to that contained in the Citizen Card, ii) the creation of a Single Immigrant Desk, enabling the access of potential immigrants, through a single point of entry, to the various services they need to contact, and (iii) the cooperation with countries of origin and transit in combating human trafficking.

Third: the promotion of immigrant reception and integration, ensuring that these individuals have a documented status, promoting family reunification, favouring mastery of the Portuguese language, the schooling of children and young people, and the education and vocational training of adults, improving the conditions of housing, health and social protection, and encouraging their integration and civic participation. Examples of measures contained in the Plan that fall under this guideline are i) the dissemination of a Welcome Guide for migrants, systematizing all the necessary information, ii) the increase in the teaching of Portuguese as a non-native language and iii) the reinforcement of the effectiveness of family reunification mechanisms.

Fourth: support of migrants' link to their country of origin and their plans to return to Portugal. Examples of measures in the Plan that fall under this guideline are (i) the *Regressar* [Return] Programme, (ii) the facilitation of 'remittance' transfer processes and (iii) the attraction of Diaspora investment.

Fifth: increased development partnerships with countries of origin and transit, thus addressing the root causes of migration and reducing the burden of factors linked to material deprivation, inequality and discrimination, lack of job opportunities and lack of minimum welfare conditions. Examples of measures contained in the Plan that fall under this guideline are (i) Portuguese participation in the new Africa-Europe Alliance for Sustainable Investment and Jobs and (ii) Portuguese development cooperation, both at a bilateral level, namely with Portuguese-speaking African countries and Timor-Leste, as well as at a multilateral level, namely within the framework of the CPLP [Community of Portuguese-Speaking Countries], the Ibero-American Conference and the European Union.

The approval of a national plan for the implementation of the Global Compact for Migration also reinforces the acknowledgement, by the Portuguese State, of the relevance of migration-related issues, already recognized in other public policy instruments in Portugal, namely the *Plano Estratégico para as Migrações* [Strategic Plan for Migration] 2015-2020, approved by Resolution of the Council of Ministers no. 12-B / 2015, of 20 March, the *IV Plano de Ação para a Prevenção e o Combate ao Tráfico de Seres Humanos* [Fourth Action Plan for the Prevention and Fight against Human Trafficking] 2018-2021, approved by Resolution of the Council of Ministers no. 80/2018, of 19 June, and the *Estratégia de Gestão Integrada de Fronteiras* [Integrated Border Management Strategy], approved by Council of Ministers Resolution 104/2017 of 17 July.

Finally, with a view to fulfilling the commitment to promote the periodic and inclusive evaluation of the implementation process of this plan, an inter-ministerial coordination committee responsible for this task shall be created.

Thus:

Under the terms of paragraph g) of article 199 of the Constitution, the Council of Ministers shall hereby:

- 1 Approve the National Implementation Plan of the Global Compact for Migration (Plan), which is an annex attached hereto and forms an integral part hereof.
- 2 Create an interministerial committee to oversee the implementation of the Plan.
- 3 Determine that the inter-ministerial coordination committee, referred to in the foregoing paragraph, is chaired by the Government member responsible for the area of presidency and administrative modernization, and shall include the Government members responsible for the areas of Foreign Affairs, Home Affairs, and Labour, Solidarity and Social Security, without prejudice to committee members being able to invite members responsible for other government areas to participate in its meetings, when deemed necessary.
- 4 Establish that the inter-ministerial coordination committee meets on a quarterly basis to review and evaluate the implementation of the Plan, and its members shall not receive any compensation or allowance for their participation in the meetings.
- 5 Create a network of focal points, each of whom is responsible for ensuring the contribution of the bodies, services and entities of the respective Government area to the definition, articulation, convergence and implementation of the measures, actions and projects contained in the Plan.
- 6 Determine that, for the purposes of the preceding paragraph, a focal point should be designated by each Government area listed in the appendix to this resolution.
 - 7 Determine that this resolution shall take effect on the day following its publication.
